### New in This Release

- List of Contacts now shows the list of <u>Unconfirmed Emails</u> as part of the customer registration process.
- <u>Property History</u> now lists type of sale by transaction type.

# **Stewart Now Portal**

### **New Customer Usage Report**

A new <u>Customer Usage Report</u> has been added to help BDOs monitor which customers are using Stewart Now, what they're using it for, and when.

To begin a **Search**, select the **Branch Name** and/or the **BDO** from the drop-down. The report will show the number of times a customer has performed a Property Search, a Property Search that had to go the Data Trace, Created Farms, Downloaded Documents or Created Net Sheets..


