Stewart Now Mobile Enhancements

The following enhancements were made for **Stewart Now Mobile (iOS/Android)**:

Display Optimization for iPhone Notch

To better display the items on-screen, the mobile app has been optimized for the camera notch for devices like **iPhone X** and above.

Facial and Biometric Login

To save time while logging in, users can now log in through **Facial Recognition** and **Biometric/Fingerprint**. Users will first need to register their face for **Facial Recognition**, and fingerprints (on devices with **Home** button and **fingerprint reader**) for **Biometric** login.

Smart Farms Report – iPad Export

With the latest iOS update, users with iPad devices can now export **Smart Farm Reports**.

Stewart Now Portal Enhancements

The following enhancements were made for **Stewart Now Portal**:

Florida and Arkansas – Email Notification

For offices in *Florida* and *Arkansas*, a **Welcome to Stewart** email notification has been enabled by default for any new user created in Stewart Now via the **ResWare Integration** and their **role in the transaction** is **Finance Professional**, **Real Estate Professional** or **Real Estate Assistant**.

Stewart Now Defect Fixes

The following defects were fixed in this release of Stewart Now:

- For the **Web Portal**, a bug was fixed in **Admin Tools**, where users were unable to update **Escrow Numbers**.
- For the **Web Portal**, a bug was fixed where **External Escrow Officers** were not able to see or change **Escrow Numbers**.
- For the **Web Portal**, a bug was fixed where **Transactions** that only had an **External Service** trying to auto-close but instead displayed an error message.
