• FORECLOSURE MORATORIUM LEGISLATION-New Law and Underwriting Guidelines Massachusetts has enacted a new law that places a moratorium on evictions and foreclosure during the Covid-19 Emergency. The law can be viewed at the following link: https://malegislature.gov/Laws/SessionLaws/Acts/2020/Chapter65

In addition, it is important to remember there has also been federal legislation relative to foreclosures and evictions, as well as implementation of suspensions of foreclosures by HUD, Fannie Mae, Freddie Mac, and the Veterans Administration. The various laws and agency-imposed moratoriums will affect the ability to insure property which is derived through a foreclosure proceeding. Please contact one of our underwriters prior to insuring any property where title is derived from a foreclosure which was commenced or completed on or after March 1, 2020.

In addition, although it may not directly apply to insurability of properties, you should be aware that both the federal and Massachusetts laws prohibit evictions, with limited exceptions. If your transaction involves rental property, you should review these laws prior to committing a seller to deliver the property free and clear of tenants.
