In an effort to keep you aware of developments and information which is important to your practice below is some information we hope you will find useful.

- <u>NEW LEGISLATION: "An Act to Address Challenges Faced by Municipalities and State Authorities</u> <u>Resulting from COVID-19" – Chapter 53 of the Acts of 2020</u>
 - Among other things, the law allows a municipality to extend the due date for the fourth quarter FY2021 (or second half FY2021) real estate tax bill beyond the May 1 date to a date not later than June 1, 2020. Because this is only an option, you should check with each City or Town to determine if the Mayor or Board of Selectmen has decided to adopt an extension.
 - The Act also suspends the deadline for a municipality to exercise its right of first refusal to purchase property under MGL c. 61, 61A, and 61B during the Governor's state of emergency and for 90 days thereafter. - <u>Bulletin MA2020001- Suspension of Deadlines and Extension of Statutes of Limitation</u> On April 3, 2020 we issued a bulletin advising our agents of the Supreme Judicial Court order relative to the suspension of deadlines and extension of statutes of limitation. As a result of the SJC's order, certain liens and encumbrances on title may be extended.
