## Stewart – Massachusetts Mid-Week Update – February 3, 2021

We hope that you made it through the first February snowstorm – it looks like we may be seeing more snow this coming weekend. Good news if you are able to take some time away to go skiing! In this update we wanted to let you know of a few recent changes made by the Biden administration and the federal agencies that will affect mortgage lending. We also wanted to remind those of you who use iPhones or iPads that Apple recently released an important security patch. On a sad note, we wanted to pass on the link to the obituary for Dr. Frederick Kalisz, the Bristol County Southern District Register of Deeds and the former Mayor of New Bedford, who passed away on January 27.

• Expanded Mortgage Eligibility for DACA Recipients

On January 20, the Federal Housing Administration (FHA) announced that people living in the United States under the Deferred Action for Childhood Arrivals (DACA) program who are also permitted to work here will be eligible to apply for mortgages insured by FHA. This is a change from HUD's prior announcement in June 2019 that DACA recipients were not eligible to apply for FHA-insured mortgages. • Mortgage Loan Limits for 2021

Each year agencies publish maximum dollar limits for each of the mortgage lending programs. The Federal Housing Finance Agency set the limit for a conventional loan is \$548,250 for most single-family properties, but can be as much as \$822,375 in some higher cost of living jurisdictions.
