#### Stewart – Massachusetts Mid-Week Update – May 13, 2020

Dear Stewart Partners,

As always, we hope that you, your colleagues, and family remain healthy and safe. Other than some snow-showers last Saturday in parts of Massachusetts, it has been a somewhat uneventful week, with only a few distributed bulletins, which we will highlight below. In addition, we want to make you aware of the following information which you may find useful.

### • <u>Geographic Targeting Order – RENEWED</u>

The GTO is not new to Massachusetts, but it is important to know that FINCEN <u>has</u> renewed the order. As a quick reminder, as a title insurance issuing agent, you are included in the reporting mandate outlined in the order.

- The reporting requirement is triggered when you are issuing a title insurance policy in transactions that meet the following conditions (defined as "Covered Transactions" in the GTO order):
  - Residential property
  - Located in **Suffolk** or **Middlesex** County
  - Buyer is a Corporation, LLC, Partnership (or similar business entity), but excepting those legal entities which are publicly traded or registered with the SEC
  - Purchase price is **\$300K** or more
  - Not financed with a bank loan by an institutional lender

### • <u>Preventing Wire Fraud Incidents</u>

It has been widely reported that one of the unfortunate by-products of the social distancing stemming from COVID-19, is the increase risk of fraud, including wire fraud. Given that work environments have changed, and your staff may be working remotely either full or part time, it is prudent to evaluate and review with your staff the firm's established protocols and to educate your clients.
