We want to share with you again the Safety Compliance Mandates, in case you missed them last week, along with some additional information you may find useful.

- Massachusetts Re-Opening Plan Safety Compliance Mandates for Essential Businesses
   As title attorneys and real estate settlement offices, your businesses were considered essential and could maintain operations and may continue to do so; however, with the Governor's announcements, even essential business have certain safety compliance mandates that must be met by May 25, 2020:
  - > Create a written COVID-19 control plan

The control plan outlines how the business/workplace will prevent the spread of COVID-19. This plan does not need to be submitted to a state agency, but it must be retained on the premises of a business and be provided in the event of an inspection. ## Post a compliance attestation poster

Businesses are required to **sign** a poster, attesting that the business has completed a COVID-19 control plan, which signed poster must be posted on the business premises so that it is visible to employees and visitors. Post rules for maintaining social distancing, hygiene protocols, cleaning and disinfecting. This requirement includes posters for employees and employers that are to be posted in the workplace. ### • FEDERAL FORECLOSURE and EVICTION MORATORIUMS

There are various foreclosure and eviction moratoriums which have been implemented and extended to **JUNE 30, 2020.** Links to the mortgage specific moratoriums are below. Depending on the kind of mortgage, different rules will apply. It is important to remember that, at present, any foreclosure auction which occurred during the declared Massachusetts State of Emergency is not insurable. If you are insuring title deriving out of a foreclosure, please contact your Stewart underwriter or email: <a href="massawing@stewart.com">massawing@stewart.com</a> to determine if the transaction is insurable and if there are additional requirements given the various foreclosure and eviction moratoriums currently in place.

Vishing is a form of attack that attempts to trick victims into giving up sensitive personal information over the phone. While that makes it sound like an old-fashioned scam, vishing attacks have high-tech elements. For example, they involve automated voice simulation technology, or the scammer may use personal information about the victim harvested from earlier cyberattacks to put them at ease.
