## • TRID and 3-Day Disclosure Requirement Waivers

O As many of you may remember, one of the big changes under TRID and the move away from the HUD Settlement Statement to the CD and LE was the 3-day disclosure requirement, which did not permit a lender to close a transaction until three days after the closing disclosure had been provided to the borrower. The waiting period could be waived if the consumer/borrower could demonstrate a bona fide personal emergency. In light of the financial emergencies which some consumers are facing due to COVID-19, the CFPB has published guidance to clarify that consumers can exercise their right to modify and waive certain required waiting periods.
