#### • <u>New Phishing Scam – Malicious Apps Asking for Extra Permissions</u>

We've learned of a new phishing scam which involves third-party apps that request unusual permissions. Users may be fooled into downloading these third-party apps because they are registered with legitimate app stores and are designed to work in conjunction with popular products such as Microsoft OneNote or GSuite. The app itself appears to be harmless based on what has been reported by KnowBe4.com, a security awareness training company, however, shortly after downloading the app you receive an email related to the app. The email you receive includes a phishing link. If you click this link, it will cause the third-party application to request special permissions such as the ability to read and write to files on your behalf. If you grant the app these permissions, you will have inadvertently given unlimited access to your sensitive information.

Don't fall victim to this scam! Remember the following:

- ✓ Never click on a link within an email that you weren't expecting.
- ✓ Only download apps from trusted publishers. Remember, anyone can make an application and scammers can use any image, text, or logo to make the app seem legitimate.
- ✓ When using a work device, reach out to your IT department before downloading new apps or granting app permissions. They can decide if the application is legitimate and safe to use.

# • Home Sales are up Compared to 1 Year Ago

A recent article in Market Watch reported that on a national level home sales and contract signings were up, notwithstanding the pandemic, compared with the same period last year. The increase is attributed to the low mortgage rates, among other factors. The Northeast led the group, where home sales were up over 50%.
