• Bulletin on claims avoidance – fraudulent land sale schemes

Stewart's claims avoidance group recently issued a bulletin warning agents of the reemergence of an older scam that has become popular with fraudsters seeking to make a quick buck. The scam involves an attempted sale of property by a fraudster impersonating the real owner. These sales usually involve vacant properties and the dealings are done via email, text and phone – the individuals involved generally don't meet with a title agent in person.
