• FinCEN GTO RENEWED

The FinCEN GTO has been extended to May 4, 2022. As a reminder the GTO requires you, as the title agent, to report covered transactions to the government through their filing portal. Covered transactions include transactions where title insurance is being issued on purchase for residential property, financed without institutional mortgage loan, located in Middlesex and Suffolk County, in the amount of \$300,000+, where the buyer is an entity as defined in the order.
