Stewart reports big drop in wire fraud risk with CertifID

Last year the FBI reported a sixty-four percent increase in overall cybercrime losses, and despite that increase, Stewart has seen a significant reduction in wire fraud risk to parties involved in transactions where CertifID's PayoffProtect service is used. Mortgage payoff fraud alone makes up approximately forty-five percent of fraud losses reported to CertifID. In 2022 CertifID launched PayoffProtect to address mortgage payoff fraud. Tom Cronkright, co-founder and Executive Chairman of CertifID says "The core mission of a title agency has always been to protect the homebuyer and seller. Now that protection includes zealously safeguarding their funds given the exponential rise of cybercrimes targeting our industry." In 2020, Stewart Information Services Corp. partnered with CertifID. Upcoming webinar: The Good, the Bad, and the Ugly: An Outlook for Real Estate and the Economy

Since the pandemic the U.S. has seen record-low 30-year fixed-rate conventional mortgage rates that have since more than doubled and are now edging to the highest seen in 20 years, the highest inflation rate cycle in four decades, all-time record employment numbers despite losing 22 million jobs in 60 days from February to April 2020, recent layoffs of 10s of thousands of high-tech workers, record commercial real estate sales in Q4 2021 -- almost double any other quarter in history, and now plunging existing housing sales – with September 2022 closings down 29.5 percent versus a year ago. There are also recession
