In this week's update we are alerting you that the temporary Remote Ink Notarization legislation which allowed for video assisted notarization expires today, December 15, 2021. • Temporary Remote Ink Notarization in Massachusetts expires on December 15, 2021

As you all may recall, during the early days of the State of Emergency in 2020, the legislature enacted emergency legislation allowing for Remote Ink Notarization ("RIN"). The emergency legislation was to expire 60 days after the end of the declaration, but was subsequently extended through December 15, 2021. This date has not been extended. Given the termination of the ability to use RIN as an acceptable method of acknowledging documents, please be sure to verify that any documents you receive for recording contain an original wet signature for both the notary and the signer.
