## ALTA's Cybersecurity Incident Response Template

ALTA has announced that its Information Security Work Group has put together a comprehensive template for use by title companies to help them develop and document a strategy to prepare for, identify, respond to, and recover from a cybersecurity incident. Dorothy Anderson, First Assistant Bar Counsel, recently published an article about an attorney's obligations relative to unclaimed IOLTA funds. As you may recall, in October of 2020, the Supreme Judicial Court issued its decision in Matter of Olchowski and held that unclaimed IOLTA funds do not escheat to the Commonwealth as abandoned property, but rather should be turned over to the Massachusetts IOLTA Funds Committee. In the article published by Attorney Anderson, the BBO strongly encourages attorneys to "clean up" IOLTA accounts now. New rules have been proposed to amend the current Massachusetts Rules of Professional Conduct to align with the SJC's decision. Currently, the Standing Committee on the Rules of Professional Conduct is reviewing comments it has received from interested parties on the proposed changes.
