Declarations of Homestead – Check your forms!

A recent Order from the U.S. Bankruptcy Court for the District of Massachusetts serves as a reminder to practitioners that formalities are important when it comes to Declarations of Homestead. The Order, issued on April 18, 2022 in the case of Danny Luu (docket no. 21-40233-CJP) upheld the objection of the Bankruptcy Trustee to the debtor's recorded Declaration of Homestead because it lacked the "penalties of perjury" language required by MGL c. 188, s. 5. Judge Panos, while recognizing the Bankruptcy Court's long history of construing the Homestead statute broadly in favor of debtors who claim the exemption, nonetheless predicted that the Massachusetts Supreme Judicial Court would hold this Declaration invalid based upon the plain language of the statute. As a result, the debtor, in this case, was only entitled to the \$125,000 automatic exemption, not the full \$500,000 that a recorded Homestead provides.

Scams Involving Sales of Vacant Lots

Last week, Stewart issued Claims Avoidance Bulletin SLS2022004 regarding fraudulent land sales. While the overall scam is the same, the fraudsters have moved on from targeting lands owned by foreign nationals and are now focusing on domestic owners. With improvements in technology and

"mail away" closings being the norm, the best way to avoid these scams is to send a letter to the seller at the address to which the real estate tax bills are mailed. In Massachusetts, most if not all Assessor's offices have this information available online.
