

Dear Stewart Partners,

It's hard to believe that Memorial Day Weekend is only 10 days away, and we'll be able to celebrate mask free! As I'm sure all of you have heard, the Governor accelerated the reopening plan for Massachusetts, and as of May 29th the face-covering order is rescinded. During Monday's press conference the Governor also announced the end of the declared State of Emergency. For more details and how this will affect your practice see the highlights below.

Although Governor's Baker's announcement is on the forefront of many of our minds, there are a couple of other items we want to share with you in this mid-week update. These include information about the SECURE Act and an article about the basics of cyber liability insurance. Also, for our border agents, we've included an update to New Hampshire's clerk's office and court house re-opening.

• Governor Baker's Covid-19 Update

On May 17, 2021, Governor Baker held a press conference where he announced that the remaining government mandated restrictions will be lifted in most public places on May 29th. Certain environments will continue to require masking, such as the T, buses, airports, hospitals, and schools. Further, the State of Emergency will be lifted as of June 15th. The end of the State of Emergency will also begin the clock to terminate the Massachusetts Remote Ink Notarization ("RIN") legislation that was enacted as a temporary law during the pandemic. This means that RIN will no longer be allowed for Massachusetts notaries as of June 18, three days after the State of Emergency terminates. In addition, the extension given to municipalities to exercise their rights of first refusal under MGL c. 61, 61A, and 61B will sunset 90 days from June 15th. • Federal Remote Notarization Legislation – The Secure Act

Although remote notarization will no longer be allowed in Massachusetts, the push to enact legislation at the federal level continues. The SECURE Act, which would allow for remote online notarization nationwide, has been reintroduced in Congress. This is a bipartisan piece of legislation that would permit remote online notarization in every state and by every notary in the country. • Reopening of New Hampshire court offices

The Supreme Court of New Hampshire has updated its emergency order governing operations effective May 18, 2021. The clerks' offices in all courts and the committees' offices will be open to the public, in keeping with the New Hampshire Constitution's requirement that "the public's right of access to governmental proceedings and records shall not be unreasonably restricted."

The clerks' offices will be open and accessible to the public for purposes of obtaining court forms, requesting information, submitting filings, or reviewing case files. With this Order, there is now "in-person" access to NH probate records. Please note, masks are required in the courthouse, including the Registry of Probate.
