As always, we hope you, your colleagues and family are well. As we enter this first week of May with Mother's Day this weekend, we want to wish all the mothers and mother figures in your lives a wonderful and happy Mother's Day.

In our first update of May we wanted to alert you that FinCEN has reissued the Geographic Targeting Order ("GTO"). The reissued GTO will be in effect through October 31, 2021, and continues the mandated reporting. For details, see below. On the technology front we've learned that Apple has released another OS update for phones and other devices. Finally, a word of caution from ALTA that the increase in cash buyers for homes has led to a similar increase in scammers targeting those buyers.

• FinCEN GTO is Re-Issued

The Financial Crimes Enforcement Unit has reissued the GTO that requires reporting for residential purchases in Middlesex and Suffolk Counties on certain covered transactions. Covered transactions include those transactions involving residential property, being purchased with cash or financed by a non-institutional lender, with a purchase price of \$300K or more, and where the buyer is an entity other than a business whose common stock or analogous equity interests are listed on a securities exchange regulated by the Securities Exchange Commission ("SEC") or a self-regulatory organization registered with the SEC, or an entity solely owned by such a business.

• <u>NEW OS updates for Apple Devices</u>

Apple released a long-awaited and most controversial update to their fleet of Operating Systems. In the latest IOS 14.5, you will be able to unlock iPhone with Apple Watch while wearing a face mask. The most controversial and publicized new feature is "App Tracking Transparency," where Apple puts you, the owner, in the driver's seat and allows granular control over an app's ability to track your activities across other companies' apps and websites.
