2021 Owner's Policy – Increase in Amount of Insurance under Condition 8

The 2021 Owner's Policy provides a number of benefits to an Insured. In this week's update, we are highlighting the increased amount of insurance available to an Insured under Condition 8 of the policy. One of the options Stewart has when it is notified of a covered claim under a policy is to bring an action to establish the title as insured. For example, if there is an assertion by an adverse party that the Insured doesn't own the land because a deed in the back chain was signed under duress and therefore void, the insurer would have the right under the policy to bring suit to establish the deed was not void. Under the 2021 Owner's Policy, if this course of action is pursued and the insurer is unsuccessful in defeating the claim, and the Insured is divested of the property, the Amount of Insurance increases by 15%, which may increase the amount of loss that would be paid to the Insured. This is an increase of 5% from the prior policy versions.
