In this week's update we first want to apologize for the bad URL link we provided to our Resource & Information Page on our Massachusetts Stewart site. Thanks to all who alerted us. We've got the right link in this update. We want to alert you to the end of the various foreclosure moratoria; however, be aware that various agencies have extended their eviction moratoria through September. For details, see below. Also, as a reminder, ALTA has recently adopted new policy and endorsement forms. For details on what you need to know now, see below. Lastly, given the prediction of a nice weekend we're sharing a link to a website with details about farmer's markets in Massachusetts. The site is searchable, by town, county, and day.

• Foreclosure Moratoria – expired / Eviction Moratoria = extended

As you know, there has been a broad ban on foreclosures, with limited exception, for the past 18 months. As of July 31, 2021, the bans by FHFA, HUD, VA, and USDA have expired and were not extended. It is important to note, that all of these agencies have extended the ban on evicting occupants of foreclosed properties. This extension will be in place through September 30, 2021. New ALTA Policy Forms and Endorsements – Published 7/30/2021

ALTA has adopted new policy forms and endorsements. Here's the confusing bit, the forms were effective 7/1/2021, but weren't published until 7/30/2021. Further, the adoption of the new forms do not retire the old forms. Stewart is working closely with software vendors to make the forms available on their title production software, but in the meantime, please continue to use the forms available to you through your software. As the forms roll out, be sure to check lender closing instructions for their required policy form.
