Why is Texas TIPS moving to hrHOME?

Texas TIPS, our Texas CE/CLE pre-recorded webinars, are moving to hrHOME for easy accessibility and management of required continuing education hours, as well as being made available as a learning tool for all Stewart Employees.

Who are the Texas TIPS webinars for?

All Stewart employees with access to hrHOME can watch the Texas TIPS webinars for educational purposes.

However, this information will be most helpful to:

- Stewart Direct Ops employees (e.g., Stewart Offices),
- Acquired Offices: (e.g., Great American Title),
- SEFS
- Attorneys and Escrow Officers
- Title Examiners, and
- Escrow Assistants

Only, Escrow Officers or Attorneys licensed by the state of Texas are eligible to receive Texas Continuing Education (CE) and Continuing Legal Education (CLE) credit, for watching *Texas TIPS* webinars.

What's CHANGING?

What's STAYING THE SAME?

- Must be licensed with the State of Texas to receive CE/CLE credit for completed webinars.
- Must complete Credit Request Form to receive CE/CLE credit.
- Must have all (4) passwords when submitting CE/CLE Request Form.
